In an effort to continue to make the NABCJ the strongest criminal justice organization and increase membership nationally the Lifetime membership has been reduced from \$750 to \$650. Ohio will extend a payment plan to its members to aid in achieving this honor. The reduction begins November 1, 2011 and expires on May 31, 2012. However all payments must be to Ohio by May 25, 2012 to allow for processing. In the event that all payments are made by May 25, 2012, you will be recognized at the 39th Annual NABCJ Conference in

New Orleans, Louisiana, July 15-19, 2012 at the Hilton New Orleans Riverside Hotel. The **Reduced** Lifetime Membership rate is **\$650.00**. Ohio currently has **39** life members and we would definitely like to increase that number by 10 before the next national conference. **Would you like to be the first to help Ohio achieve this goal?**

Some of the benefits of becoming a lifetime member are:
